The FORTIFY™ is a PE elastomer which is used as tackifier, providing excellent adhesion properties while avoiding buildup on the wrapper pre-stretch rollers (reducing downtime). SUPEER™ metallocene grades can improve efficiency through down-gauging opportunities, and high tensile strength at low elongation. It also offers high tear strength and puncture resistance with optimal stiffness.

Certain SUPEER™ grades are also available as certified renewable from SABIC's TRUCIRCLE™ portfolio, produced with second-generation bio-based feedstock to support CO2 emissions reduction.
