DECLARATION

In reply to your inquiry on HACCP compliance, we can inform you as follows:

It is the interpretation of SABIC that food safety standards e.g. HACCP (Hazard Analysis and Critical Control Points) are relevant for the manufacturing and supply of food and articles used in food packaging and filling operations. Since these food safety standards are not relevant for plastic raw material producers, SABIC has not implemented a HACCP assessment system or any other food safety standard system in its production facilities.

If needed we provide our customers with all relevant information they need to judge whether our raw materials enable them to make articles that are in compliance with the relevant regulations, standards or end market requirements.

Especially in critical areas like food contact, pharmaceutical, toy or drinking water applications SABIC has declarations available for its materials specifying compliance conditions for use or handling.

It is our policy to extend these declarations in such a way, that they give our customers more information about the recommended applications and possible restrictions of our materials. As these regulations or standards develop, our declarations are adapted accordingly.

We can also inform you that the production of our food contact materials complies with the requirements of EC Directive 2023/2006/EC (on the good manufacturing practice for materials and articles intended to come into contact with food).

On the other hand we can assure you that SABIC as a responsible producer, conducts its activities in such a manner (e.g. by good housekeeping) that they a.o. comply with the applicable laws and our SABIC Corporate Requirements.

This information applies to the material as produced in our production facilities and does not cover any additive, pigment, etc., subsequently used or added by the buyer (or a third party).

Please note carefully that regulations develop continuously and that SABIC declarations may be adapted accordingly. This declaration replaces all previous versions relating to this subject and product(s) and will be valid for a period of 3 (three) years, after which it automatically expires.
